Article published in memory of Comrade Jim Lowe, author

This is a little story of a ship of the R.C.N.V.R., which is still being written

H.M.C.S. Murray Stewart (aka Georgian Queen)

The ship I mention above, on which I spent two years of my young life in the R.C.N.V.R. during WW2, is nearly as old as I am. She has had her ups and downs just like us humans.

She was designed and built in 1928 in Midland, Ontario, for duties as a coast-guard vessel in the Great Lakes, servicing channel buoys, lighthouses, docks, etc.

In 1941 she was called into service by and for the R.C.N. as an examination vessel on the east coast of Canada, running out of Saint John, N.B. She patrolled the Bay of Fundy outside the port examining ship going into the harbour preparatory to forming a convoy and picking up cargo for overseas. The ships had to be examined for contraband and explosives, which could be used to cause damage to the port or surrounding countryside (protecting the Port). The only armament she carried, however, was a WW1 Lewis gun, which, when brought out for testing, guite often misfired or jammed.

After four or five years of active service, she was de-commissioned and put into "moth-balls" in Sorrel, Quebec, where she remained for several years before being picked up by a consortium of men from Penetanguishene, Ontario. They were planning on refitting her to become a floating grocery store to service the "Thirty-thousand Island" cottage population. However, nothing was done for several years, and the consortium fell apart. Some moved away, and others died, leaving one person to pay the dock fees on the ship, which eventually became a burden on the man remaining, who was the owner of the I.G.A. store in Penetang, who--I might add--had two ambitious sons. He then turned the vessel over to his two sons and they in turn started to refit the vessel that had sat at the dockside for a number of years. In the meantime, the kids of Penetang would climb aboard the ship and use it as a diving board. Someone finally found the sea-cocks and opened them, allowing water to come in, and the ship sank at dockside where it tilted and allowed the mast to be used as a springboard for the kids to dive from.

The two sons re-floated it, removed the superstructure and the old worn out coal burning engines, replacing it with two new diesel engines and screws, laying a new wooden deck over the old steel deck, rebuild the galley, and built a new wheelhouse and installed the latest navigational equipment, turning the ship into a tour boat cruising the "Thirty-thousand Islands", catering to weddings, birthday parties, etc. Dinners, lunches and snacks could be arranged. They changed the name to "The Georgian Queen" and a whole new life was created for the old ship.

I served on the H.M.C.S. Murray Stewart, as a signalman, in WW2, prior to my discharge, upon de-mobilization, after the war in the Pacific was over. This was a period of about two years. I lost track of the ship for many years, being tied up with raising a family, learning a trade, and earning a living.

Upon moving to Ottawa in the early 1960s for a position with N.R.C., I got to know Rick Blanchard, a close friend of my son's, and a budding journalist. In 2006, Rick was doing some research on a story about the Navy when he remembered stories I had told about my time in the service and the name of the ship I served on during the war, having some across some mention of the Murray Stewart in his searches. He contacted me about this and we found out that the ship had been sold as I have said above. Upon learning of this, I phoned the brothers and made a date to visit with them. My wife Audrey, my daughter Glenda, her husband David, and I took a trip up to Penetang to see my old friend, "The Ship." Having identified myself to the two brothers, I was invited aboard for a tour of the "Renewed Ship" and taken for a tour of the Thirtythousand Islands. The islands themselves were of no interest to me at the time, but the fact of standing on the deck of what was my home for two years, some 65 years before, was "weird" and wonderful, bringing back some vivid memories of long long ago... some pleasant, some not so pleasant.

The knowledge that my "good old ship" was still active gave me the incentive to carry on and try to live up to her reputation of renewal and longevity. You see, we were of the same vintage. She was built in 1928, and I was born in 1924, and we were both in "service" to our country in its most trying years.

Roll along, "wavy navy" ... roll along. Keep up the good work.

#### Remarks by

At the Standing Senate Committee on Legal and Constitutional Affairs

Study of Bill C-217, An Act to amend the Criminal Code (mischief relating to war memorials)

February 12, 2014

Mr. Chairman and Committee Members thank you for inviting me to contribute some personal remarks on Bill C-217. It is an honour to appear before you. I would also like to commend Mr. David Tilson, MP for Dufferin-Caledon, for introducing this private members bill; the relevance and timing of which are broadly supported by many of my colleagues.

When I was first approached by Mr. Tilson's office to participate in these deliberations, other than in a general sense, I was not aware of the extent to which the perniciousness of mischief relating to war memorials was abroad in Canada; a proud and democratic nation which commemorates and applauds the sacrifices made by its veterans in defence of our freedom and those values which most admirably define us as Canadians.

As I first read through the proposed legislation, although I generally supported the Bill, I was somewhat at odds with the measures proposed, specifically, the criminalization of such heinously disrespectful desecration as ways and means to combat such behaviour.

I thus decided to inform myself more fully on the extent and nature of mischief relating to war memorials.

Firstly, I decided to refresh my understanding of the purpose which war memorials, cenotaphs and other commemorative monuments serve; both now and throughout the past. The general definition of a cenotaph, a word which I will use to describe collectively all commemorative monuments, might read:

A monument erected to honour an individual or group of people whose remains are interred elsewhere or whose remains cannot be recovered, especially in memory of soldiers killed elsewhere.

I might also add that

Monuments also serve to permit those who have lost loved ones to bear witness that the fallen have not perished for naught and to remind all Canadians of the values we and those who went to war hold dear.

Cenotaphs have been erected since time immemorial by diverse cultures and come in many forms and sizes ranging from a simple marker to elaborate mausoleums. Their purpose is to commemorate and celebrate the sacrifices and contributions of those who fought to protect and preserve that which peoples value, that which defines them and that which is threatened. Cenotaphs are deemed sacred and constitute a place of assembly to honour and pay tribute to the fallen. Remembrance Day is such a time and place of assembly. Ceremonies of similar intent and purpose take place annually around the globe.

Secondly, I then Googled vandalism of war memorials and found, much to my dismay, disgust, shame and horror, that such desecration is not isolated but is disturbingly frequent and common in Canada and elsewhere throughout the world. Not only is vandalism rampant, it takes the form of destruction, defacement, acts of woeful disrespect such as graffiti, urination, defecation and a host of other assaults. The desecration of our National War Memorial and the Tomb of the Unknown Soldier are but a few examples. Mr. Tilson has provided ample examples of mischief so I will not dwell on these in further detail. I also discovered that measures to curb this deplorable behaviour such as community service, meeting with

veterans and other such soft remedial activity, are of little effect.

#### So what to do?

I mentioned earlier that, although I fully support Mr. Tilson's initiative to discourage and eradicate mischief relating to war memorials, I was initially at odds as to the criminalization thereof and the consequences related thereto such as the imposition of a range of graduated fines and/or imprisonment. After considerable reflection and discussions with my colleagues, I am of the conviction that there exists little choice but to criminalize mischief against war memorials and impose a range of graduated fines and/or imprisonment.

I have dedicated a considerable portion of my life to service in the military and, by extension, to my adopted country and have witnessed firsthand the brutality of war; the loss of life and tragic consequences which befall nations, peoples and individuals. I was born in The Netherlands. My parents emigrated from a country devastated by war to a land of opportunity and respect for freedom, values, honour and sacrifice for individual and collective good. It thus comes as a shock that there exist those who would deface war memorials and act with such demeaning disrespect to those who sacrificed so much to serve and protect.

I gather that some are repulsed by criminalizing this repugnant behaviour and by the imposition of associated fines and/or imprisonment. Let me state that there exist misdemeanours of less severity which fall under the criminal code and that some of these have outcomes of greater consequence. Let me also reiterate that mischief against war memorials is a grievous and heinous assault and act of woeful disrespect towards our fallen and the values which Canadians hold dear and for which Canada is acclaimed throughout the world. Permissiveness, soft consequential measures for violation of persons (and yes the fallen are persons) and property as well as dishonourable and irresponsible behaviour, do

not reflect our values. They can neither be tolerated nor condoned.

I thus fully support Bill C-217 and commend Mr. Tilson on its formulation and introduction.
