

Branch Event Ticket Sales Policy and Procedures

Issue Number: 001 Issue Date: 18/06/2014

Policy

The Branch Event Ticket Sales Policy and Procedures has been developed to allow all members the opportunity to purchase tickets for branch events in a timely fashion, and to provide adequate time for the event organizers to purchase supplies and make preparations for the event without having costly overruns.

Procedures

- 1. The Event Co-coordinator, in consultation with food preparer, will set and advertise the cut-off date for ticket sales, payment and pick-up. All tickets must be paid for prior to or on this date.
- 2. Those wishing to make reservations without immediate payment may do so; however,
 - a) They will only be put on a waiting list until the tickets are confirmed and paid for.
 - b) Their unpaid tickets could be sold close to reaching maximum attendance level.
 - c) All tickets must be paid for before the event cutoff date.
- 3. For control purposes a sign-up/purchase list and a reservation/waiting list will be kept behind the bar. All purchases and reservations must be entered on the appropriate list.
- 4. There will be no refunds given after the cut-off date.
- 5. The Event Co-coordinator will ensure that this information is disseminated to all ticket purchasers and sellers.
- 6. Any changes to this policy for special events must first be approved by the Branch Executive.

This policy statement has been approved by the Branch Executive on 12/06/2014 and ratified at the Branch General Meeting on 18/06/2014.

All the nice girls love a sailor All the nice girls love a tar All the nice girls love a tar



Although everyone knows what a sailor is, very few people know what a "tar" is. So to allay some of the myths of the sea, here are a few explanations of the uniforms of the sailor.

The Story of the "Tar" (Sailor)

Sailors, in the days of "wooden ships and iron men", were nicknamed "tars", because they not only smelled of tar, which they worked with "oakum" to repair their ships and boats, but because they didn't often take baths or change their closes very often, the tar they used stuck to their clothing and exposed areas of their bodies, such as hands, feet and sometimes chest, thus making them appear dirty and smelly from the tar.

The "oakum", mentioned above, is a rope-like coil of hemp used to fill cracks, holes and separations between the timbers and boards used to construct ships and boats. The oakum was shredded by hand, a very hard job, which broke finger nails and wore off the skin on the end of the fingers, and therefore was given to prisoners as a form of punishment.

The oakum, after shredding, was pressed into the cracks or holes and pounded in by a hammer or a blunt chisel. Tar was then mixed with other oakum and pounded in above the raw oakum. As the timbers or boards became soaked with water, they swelled up and thus tightened the oakum and tar, making the crack or hole watertight. The same process is still in use today in some well-built wooden vessels. Although with present day technology and material, it is not necessary to fill in cracks and holes, which are not present in molded hulls and plastic coverings.



More Truths about Sailors' Uniforms Let's start from the floor, or the "deck." The bell-bottomed trousers were designed to be easier to roll up above the knees, so they wouldn't get wet when the sailor was scrubbing or "swabbing" the deck.

When a sailor was "stowing", or putting away, his uniform, the pants were put in the bottom of his "sea bag." First they were turned inside out, thus forming creases on the sides of the trousers and, because the trousers were turned inside out, the creases were on the inside, an averse to the present day trousers, and becoming known as "outboard fish."

The pants were folded over right to left half way, which was approximately the width of the bottom of the sea bag. The average number of folds was seven, resulting in the common belief that the folds in a sailor's pants represented the "seven seas."

The same sailor's pants were originally designed to act as a life-saving device; begin made from a very, very close woven material, which when wet swelled up and closed the weave to a point where it became almost watertight. If a sailor found himself in the water without a boat nearby to save him, he removed his pants, tied a knot in the ankle section of the pants, holding the waistband above his head and bringing it down on the water, trapping air inside the pants, the two pant legs pointing upward in the air forming a "y" and being wet, has become buoyant and could retain the air for several hours, thus allowing the sailor to rest in the "y" until the air gradually escaped. Then he would be able to perform the operation all over again.

The sailor's jumper was designed so that it was fairly tight to the body, but when grasped at the lower point of the "v" in the neck, could be torn open and discarded quickly so that he could begin to swim and not get bogged down by clothing.

It is easy to see that most of these uniform parts were designed for tropical waters, which are slightly warmer than our northern atmospheres. The black silk ribbon, which is worn around a sailor's nick, under his collar, is commonly believed to be in memoriam of the death of Lord Nelson at the battle of Trafalgar. That is a fallacy.

When a sailor went into battle, he was given a white band to wrap around his forehead to stop the sweat from rolling down his forehead and into his eyes, thus blinding him with the salt and grime. In the heat of battle and smoke of canons being fired off a certain amount of dirt, grime and black gunpowder would collect and roll down on the silk, making it very dirty and black. When the battle was over or there was a respite in the fighting, the sailor would slip the cloth down around his neck, where it was available for the next engagement. *Ergo...* why not provide a cloth that was already black and it would not be as noticeable in the off moments.

Sailors, in the days of sailing ships, were allowed to let their hair grow as long as possible and, to keep their hair out of their eyes and clear of all hazards, they braided it into pigtails kept in place with tar or wax. In order to keep the tar or wax from ruining their jackets, they had to have a long, easily changed or removed collar under the pigtail.

This collar was to be made of denim, which was durable and easily washed, and must be separate from the uniform and easily removed for washing or replacing. To provide a little embellishment, the manufacturers, when bidding for the contract to supply the Navy, they decided to add a trip of white piping around the periphery of the collar. Each supplier tried to outdo the other with more lines of piping. Finally a little Jewish company won the bidding by putting on three lines, and the cheapest bid. Thus began the myth that the three white stripes on the collar represent the three great seas.

It is easy to see that most of the sailors' uniforms were designed for tropical waters, which are slightly warmer than our typical modern climates.

The final part of the uniform of the sailor is the hat. The hat was designed to fit into a round tin box which, in turn, was designed to fit into the sea bag. It has a stiff brim, which retains its shape when the head is rested upon it to provide a pillow, when the sailor was sleeping in a hammock or a hard wooden bunk aboard ship or in barracks ashore.

So, here you have an explanation, in common sense language, of some mythical beliefs in connection with naval gear.

Remember that a ship is a ship; a boat has oars to propel it, and a "gig", a boat with a motor and no oars.
